Community Conversations: panel discussions with mental health professionals, equity experts, celebrities, influencers, and individuals with lived experience to silence their shame, eliminate stigma and promote acceptance in their communities. Conversations are entered around mental health, trauma, suicide, and social determinants of health to more than 1,600 attendees.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Teen Cope Mental Wellness Clinics: a youth resiliency support program designed to engage in authentic and uncensored conversations with teens discussing their mental health and wellness. Youth participants engage in fitness and expression stations, where they have the opportunity to build skills that promote healthy coping and social connections. Adult participants engage in a Parent Cafe session to learn how to be trusted adults as they teach youth to cope with life's challenges, manage stress, and make healthy decisions to better promote healthy development.

Wellness Trainings: customized mental wellness seminar, workshops, and trainings on practical coping techniques, stress and anxiety management, and a wellness curriculum for employees and leaders. In addition, the program offers suicide prevention training to educate participants on identifying symptoms and supporting individuals in a mental health crisis.
