The Silence the Shame University (STSU) College Ambassador Program empowers diverse college students and young adults to serve as mental health advocates on their campuses and communities. The program fosters mental health awareness, supports help-seeking behaviors, and cultivates a network of current and alumni ambassadors committed to improving access to behavioral health resources.
